


A Culture of Giving

BECKER CAPITAL'S 2023 DONATIONS BY SECTOR



- Created a multi-year strategy for a school to expand and professionalize their fundraising activities, and
- · Developed a leadership succession plan.

While these were some of the discrete "projects" that we have successfully tackled, they have also deepened understanding of our clients and strengthened our partnerships. Building trust through meaningful engagement allows us to become allies to nonprofit leaders and boards, ready to support their endeavors and contribute to their audacious goals and wholistic success.

Casey Boggs facilitated discussions and provided processes for nonprofit executives and board to identify and prepare for issues such as cyberattacks, employee malfeasance, financial distress, on-property violence and social media dilemmas.

In addition to the workshop portion of the day, a professional photographer was on location to take complimentary headshots for those in attendance. Nonprofit partners and members of the Becker Capital team enjoyed an alfresco lunch ahead of the workshop and wrapped up the day connecting during happy hour.

We are implementing a community engagement platform, Field Day, to assist us with finding new opportunities to serve the community and its nonprofit organizations.


This platform drives social impact and employee engagement and allows for the creation of employee volunteer experiences that build connection, foster community, and strengthen culture in the workplace.
